| Annotation of the course content |
| <p>The course allows to get acquainted or to deepen the knowledge with classical and modern theories of narrative and narrativity. How Aristotle's theory of intrigue differs from the structuralist narrative theories of the 20th century. How the classical theory of intrigue has been developed in the 20th century (the work of P. Ricoeur, R. Baroni, etc.). Structuralist narrative grammar. Narrative and narrativity. Narrative and poetic. The system of narrative language and the different ways of describing it: between paradigmatics and syntagmatics (Cl. Levi-Strauss, V. Propp, C. Bremond, Cv. Todorov, U. Eco, A. J. Greimas, R. Barthes). Narrative structure: topology and seriality (Cl. Levi-Strauss, J. Lacan), grammar (Greimas), poetics (G. Genette). The logic of narrative (structuralism: Cl. Levi-Strauss, A. J. Greimas) and the time of narrative (phenomenological hermeneutics: P. Ricoeur, R. Baroni; Genette's narratology). Syntax and semantics of narrative: between A. J. Greimas and R. Barthes (readings of Maupassant and Balzac). Narrative discourse: notions of discursivity (Genette, Greimas, D. Cohn, A. Banfield). Narrative as a system of communication. The question of narrative identity (Ricoeur). Narrative in fiction and historical discourse.</p> |
