Annotation of the course content

The aim of this course is to research Lithuanian exile poetry of the post-WWII period (1940-1990) emphasizing the prevailing Modernist paradigm of aesthetics. The works of poets' generation *Žemininkai* of the early post-war period were deeply influenced by Existentialist philosophy (they borrowed the name of the group from poetical anthology *Žemė* [*The Land*, published in Los Angeles, 1951]. Those Northern America-based poets (K. Bradūnas, A. Nyka-Niliūnas, H. Nagys) created a magazine *Literatūros lankai* [*Literary Sheets*] (1952-1959, published in Buenos Aires) and focused on Modernist Western literature, thoroughly examined the debates on Modernist music, art, theatre, cinema. By that time, Lithuanian émigré writers realized their exclusive role as they had a privilege to spread Modernist ideas while literary field of Soviet-occupied Lithuania was dominated by dogmatic Social Realism and totalitarian censorship. The course material consists not only of poetry but also of letters, diaries and translations. The main aspects: academic environment that helped to develop the *Žemininkai* generation; Existentialism as an intellectual trend; individual attempts to meditate on heritage of Western thought; relations of Catholic-reformist thinkers Antanas Maceina and Juozas Girnius with *Žemininkai* group. The predominance of right-wing Catholic ideology in the diaspora and agnostic manifestations in the exile Modernism. The legacy of Vytautas Mačernis (1921-1944) and self-estimations of generation. Conflicts with earlier Neo-Romantic generation which prevailed in the literary field of the last decade of independent Republic of Lithuania (1930-1940). The main target of Lithuanian Modernist criticism of 1950's was the lyrical tradition of Neo-Romantic trend. The poetical evolution of Alfonsas Nyka-Niliūnas and semantic isotopies of his works. The repertoire of conceptual and intellectual poetry. Meditations on the Modernist literature in A. Nyka-Niliūnas' diaries. Henrikas Radauskas as a medium between Modernist and Neo-Classical aesthetical trends. The influences of German Expressionism and French Symbolism. Which Western poets were translated, reviewed and praised in the Modernist criticism? Henrikas Nagys as a Modernist poet full of emotional tension. Jonas Mekas: poetical reflections of everyday existence and radical programs of avant-garde. Aesthetical programs of Liūnė Sutema and Algimantas Mackus, the most characteristic representatives of *Bežemiai* generation ["Those who lost their land"]. Modernist poetic tradition as an integral part of the classical Lithuanian literary canon of the 20th century. The role of exile-based literary critics legitimizing the poetics of Modernism.
