Annotation of the course content

The course is intended for PhD students from literary studies, linguistics, folklore, history and philosophy, whose research interests include the scholarly editing (critical and genetic) of the written heritage, state and public documents, egodocuments, literary and philosophical works, and folklore as well as the critique of such publications. The course aims to examine the approaches to scholarly editing from the second half of the 20th century to the beginning of the 21st century and to train in the recognition and application of different scholarly editing methods. Since the diversity of contemporary approaches to academic editing is a result of the challenging concept of the text, the theory of the text is discussed as the fundamental and methodological basis of the subject. The topic is examined in the broad context of traditional philology, modern and postmodern humanities undertakings and cultural studies. The diversity of conceptions of text, work, document, source, inscription, reading, performance, and the conundrums of practical solutions to textual criticism posed by the concepts of the relationship between the speech act and the inscription, the conventional nature of signification, the thresholds and coherence of the text, textual interference, and the instability of the text are discussed. Examples from historiography, Lithuanian and general literature reveal how the definition of the text, approaches to the genesis, structure and functioning of the text determine the interpretation of the historical document and the literary phenomenon. The perspectives of 'text-work', 'text-author', 'text-social', 'text-culture', 'textdiscourse', 'text-the Text' are examined. Questions of uniqueness and repetitiveness of the text and translation are addressed. The derivative concepts of 'intertext', 'hypertext', 'metatext', 'architext', 'polytext', linguistic and non-linguistic textuality are considered from the point of view of different concepts of the text and methods of scholarly editing. The possibilities of digital publishing and the methodological debates they provoke are introduced. Knock around self-guided attempts to apply different editing, annotating and apparatuses types to challenging texts prepared for traditional and digital dissemination.
