Course annotation
The definition, characteristics, criteria for differentiation and relativity of asocial behaviour. Psychological theories of asocial behaviour (psychodynamic, social learning, social cognitive, rational choice, etc.). Problems of conceptualization of asocial behaviour.
The definition, main forms and theories of aggression (instincts, frustration-aggression, social learning, social cognitive, the general aggression model). Sexual aggression and theories of sexual offending (social learning, evolutionary and integrative). Problems of conceptualization of aggressive behaviour.
Psychological characteristics of addictions: alcohol and drug dependence, pathological gambling. Development of physiological and psychological addiction and its results. Psychological features of "dependent personality". Strategies of coping with different addictions and its problems.
Suicidality and suicidal ideation. Main forms and psychosocial sources of suicide. Peculiarities of juvenile suicide. Problems of prevention of suicide behaviour.
Main forms of criminal conduct and their psychological characteristics (theft, vandalism, murder, terrorism, etc.). Peculiarities of criminal conduct's motivation. Strategies of criminal conduct's prevention and its problems.
Risk and protective factors for asocial behaviour: individual, family, peer, school, community and media. Problems of determinism of asocial behaviour.
The mechanisms underlying the development of asocial personality (classical and operant conditioning, identification, modelling, social information processing, neutralization of internal and external controls, etc.). Interaction of internal and external factors underlying the development of asocial personality. Problems of control of asocial personality's developmental mechanisms.
Psychological aspects of the prevention of asocial behaviour (stages, strategies and principles of the prevention, common factors in effective prevention programs, etc.). Approaches to treatment of offenders. Issues and prospects of psychosocial support to offenders.
