Purpose of the course unit (module): programme competences to be developed

A focus on British cultural identities immediately raises a number of questions: Whose Britain? Whose culture? Cultures rather than a culture? Whose identity? Do a majority of people in the UK think of themselves in terms of being British anyway? The course begins with a spotlight on aspects of being British, then moves on to understand British cultural identities by looking at the Cultural Geography of Britain, Education, Work and Leisure, Gender Identity and Sex, Youth Culture and Style, Social Class Identity, Ethnicity and Language, Black British Identity, and Religion. The course concludes with an assessment of Cultural Heritage in Britain. During the course, students will get acquainted with the various ways to study and interpret cultural practices associated with identities. Combining lectures with practical seminars, students will be enabled to produce an essay project on a British cultural identity(ies) of their choice. Clips from Youtube* will be accessed, and Lecture notes will accompany each topic (to be accessed on group website).
