Purpose of the course unit

This module aims to provide legal and practical knowledge about the main forms of business organisation, discussing in detail the company's legal form and comparing it with other legal forms of company-private legal entities. Skills are developed to differentiate the forms of business organization in key aspects, as well as to identify and solve the essential problematic aspects related to the legal form of the company. In the subject of business law, the general part of business law is examined in theoretical and practical aspects, and the rules for the implementation and protection of civil rights are analyzed in detail. It also introduces the main concepts and doctrines of contract law, corporate law, agency law and other branches of commercial law, regulation of obligations and principles of contracts. The regulation of the activities of business entities and the legal regulation of representation, transactions and the grounds for their invalidity are analyzed.
