When the Minister amends the standard cost of tuition, the cost of annual tuition at Vilnius University is amended accordingly without an additional legal act of Vilnius University.

<sup>2</sup> A non-refundable deposit of EUR 1,000 which is part of the tuition fee is applied to the nationals of the Kingdom of Norway and the Kingdom of Sweden applying to the Medicine and Dentistry study programmes.

<sup>3</sup> The cost of annual tuition applied for the EU and European Free Trade Association nationals is EUR 3,620 (EUR 60.33 per one credit).

<sup>4</sup> The standard cost of tuition is applied for the graduates of Vilnius University and 'Vilnius University International Business School' VŠĮ, and the exchange students of Vilnius University. The cost of annual tuition applied for the EU and European Free Trade Association nationals is EUR 4,980 (EUR 83 per one credit).
