



**RESOLUTION  
OF THE SENATE  
OF VILNIUS UNIVERSITY**

**ON THE PROPOSAL OF CANDIDATES FOR THE 2024 ELECTION OF MEMBERS OF  
THE YOUNG ACADEMY OF THE LITHUANIAN ACADEMY OF SCIENCES**
